AN ORDINANCE AMENDING ORDINANCE 110 ENTITLED AN ORDINANCE GRANTING A CABLE TELEVISION FRANCHISE IN THE CITY OF MOOSE LAKE, TOWNSHIP OF MOOSE LAKE AND TOWNSHIP OF WINDEMERE, TO NORTH AMERICAN COMMUNICATIONS CORPORATION, AND RULES GOVERNING THE OPERATION OF SAME

The City Council of the City of Moose Lake, Minnesota, does ordain as follows:

Section 1. That item 3 of the DEFINITIONS section hereby be amended to read as follows:

"Franchisee" and/or "Company" is Star North American Corporation.

Section 2. That Section 36. Franchise Fee of Ordinance 110 hereby be amended to read as follows:

## 36. FRANCHISE FEE:

Effective January 1, 1992, the Franchisee shall pay a franchise fee equal to five percent (5%) of its gross annual subscriber revenues. Said fee shall be payable to Franchisor semi-annually, on March 31 and October 30 of each year. Gross annual subscriber revenues means any and all compensation received directly or indirectly by the Franchisee from subscribers for cable communications service. Gross annual subscriber revenues shall not include revenue derived from advertising revenues, installation charges, or any taxes on service furnished by the Franchisee imposed directly on any subscriber or user by any city, state or other governmental unit and collected by the Franchisee for such governmental unit. CATV service means the distribution of broadcast television, radio signals, any communications service in addition to basic CATV service provided by the Franchisee either directly or as a carrier for its subsidiaries, affiliates, or any other person engaged in communications service, including, but not limited to, pay TV, data or other electronic transmissions service, and facsimile reproduction service.

The Franchise Fee increase shall be in lieu of Star North American Corporation being required under the terms of the Ordinance to maintain the public access TV equipment. Star North American Corporation, upon passage of this Ordinance, shall transfer by Bill of Sale all of the TV equipment hereinafter set forth to the City of Moose Lake. The City of Moose Lake shall be responsible for maintenance of the public access studio equipment and the

replacement of said equipment as the same becomes necessary out of the proceeds of the Franchise Fee. The equipment to be transferred pursuant to this paragraph shall be as follows:
